Privacy Statement

Privacy and storage of personal information

Questacon is bound by the Australian Privacy Principles (APPs) outlined in [Schedule 1](#) of the *Privacy Act 1988* (Cth) (Privacy Act) which regulates how entities may collect, use, disclose and store personal information.

Use of personal information

The personal information of you or your child or the child for whom you are acting as guardian is being collected by Questacon as part of its **Science in First Languages (SIFL)** online gallery, which will be hosted on YouTube. Questacon will make SIFL videos available to the public and will share the videos with its affiliate and sponsors. From the video footage and application form, Questacon will collect your personal information, including:

- the video footage, voice recording and/or still images of you or your child or the child for whom you are acting as guardian;
- any personal information of you or your child or the child for whom you are acting as guardian contained in or revealed by the video footage, voice recording and/or still images, including:
 - age
 - ethnicity
 - name of your/their workplace/school/town/suburb
 - school year level.

The personal information of you or your child or the child for whom you are acting as guardian will be used for the production and distribution of educational or promotional material through media such as:

- publications including newspapers and magazines;
- electronic and printed advertisements;
- televised activities including news broadcasts, advertisements and promotional features;
- Questacon publications including newsletters, brochures, posters and annual reports, video productions;
- intranet and internet sites (World Wide Web), including social media sites such as Facebook, Twitter and YouTube;
- exhibits and exhibitions, educational program content and associated collateral; and
- to allow the Department to contact you to clarify or provide further information on any aspect of your submission.

Information is being collected for the purpose of:

- promoting the United Nations International Year of Indigenous Languages 2019;
- promoting Questacon's public awareness campaign;
- publicising Questacon's exhibitions, activities and programs to target audiences, including potential sponsors; and
- promoting the outcomes of Questacon's sponsored exhibitions, activities and programs to affiliate and sponsors' target audiences and stakeholders.

As part of the above purposes, the personal information of you or your child or the child for whom you are acting as guardian will be published on the internet and shared with Questacon's affiliates and sponsors. Questacon's affiliates and sponsors include the:

- Australian Institute of Aboriginal and Torres Strait Islanders Studies;

- First Languages Australia;
- Department of Communications and the Arts;
- Australian Broadcasting Corporation; and
- Department of Industry, Innovation and Science.

This means that the personal information of you or your child or the child for whom you are acting as guardian will be accessible to millions of web users across the world, will be indexed by search engines and may be copied and used by any web user.

By signing this form, you consent to Questacon publishing the personal information of you or your child or the child for whom you are acting as guardian on the internet and acknowledge that this personal information will be accessed by third parties. You acknowledge that once the personal information of you or your child or the child for whom you are acting as guardian has been published on the internet, Questacon has no control over its subsequent use and disclosure.

You acknowledge that Australian Privacy Principle 8.1, contained in the *Privacy Act 1988* will not apply and that overseas recipients may not be subject to the *Privacy Act 1988*. You also acknowledge that Questacon will not be liable if a third party (including overseas recipients) handles the personal information of you or your child or the child for whom you are acting as guardian in a way that breaches the *Privacy Act 1988*, and that you will be unable to seek redress under the *Privacy Act 1988*.

By providing your consent to the disclosure of the personal information of you or your child or the child for whom you are acting as guardian to our affiliates and sponsors, you acknowledge that if an affiliate or sponsor handles Information in breach of the Australian Privacy Principles, Questacon will not be liable under the *Privacy Act 1988* (Cth).

You do not have to give your consent. **If you do not provide your consent, Questacon will be unable to publish the submitted video.**

Personal information obtained will be stored and held in accordance with the Questacon's obligations under the *Archives Act 1983* (Cth). Personal information obtained will only be used and disclosed for the purposes outlined and will not be used or disclosed without your consent, except where authorised, or required by law.
